

FINIMA NATURE PARK Week 13 Report

Highlights: General anti-poaching patrol and biological monitoring was conducted round the park and observations were noted, no arrest was made. Troops of Mona Monkeys, Green emerald snake, birds, Beetles, butterfly, skink, Dragonfly and Monitor lizards were sighted.

Outreach & Engagement: There was no school visit under this reporting period as all the schools have vacated and are now on break.

Tidiness & Cleanliness: Tidiness of the Board walk and other Park facilities werecarried out during the reporting week i.e. sweeping of the trail, clearing and cutting of tree branches that fall along the board walk. Also trail inspection was carried out during the week; some broken trails were discovered and fixed accordingly.

Reforestation program: In an attempt to restore the part of Ngalanga forest that was razed by fire, 400 mangrove propagules were transported there for planting. The propagules comprises of 170 species of *Lophira alata* and 230 *Cleistopholis patens*. There is plan to plant more of these species of trees to other identified degraded part of the forest.

Coastal erosion & Encroachment: Monitoring of coastal erosion is ongoing, as observation shows that siltation and deposition of debris along the shoreline persist. Coastal area measurement from Ship Wreck is 150m away from the Sea and 110m away from the Hippo creekwhile it is 95m awayfrom the Almond Tree respectively.
